For those pieces of equipment that require annual certification (BSC, laminar flow hoods, clean benches, chemical fume hoods, safety showers, eye wash stations) these must be added to your laboratory so EHS can make arrangements for certification.

<u>NOTE</u>: If your equipment is not listed, you may be overlooked and miss annual certification.

Additionally, if your laboratory utilizes equipment that requires monthly validation such as an autoclave, be sure to upload your autoclave log sheet as well as your monthly sterilization SOP into the documents tab.










Adding New Lab Staff





New or exiting lab members can be easily added/removed from BioRAFT.


Within the Members Tab, you can add your new staff member, assign their designation and allow optional access to various levels of your BioRAFT lab profile.

Training modules are directly tied to specific job duties within the lab. Depending on their job within your lab, training notifications may be sent as soon as they have been added.




